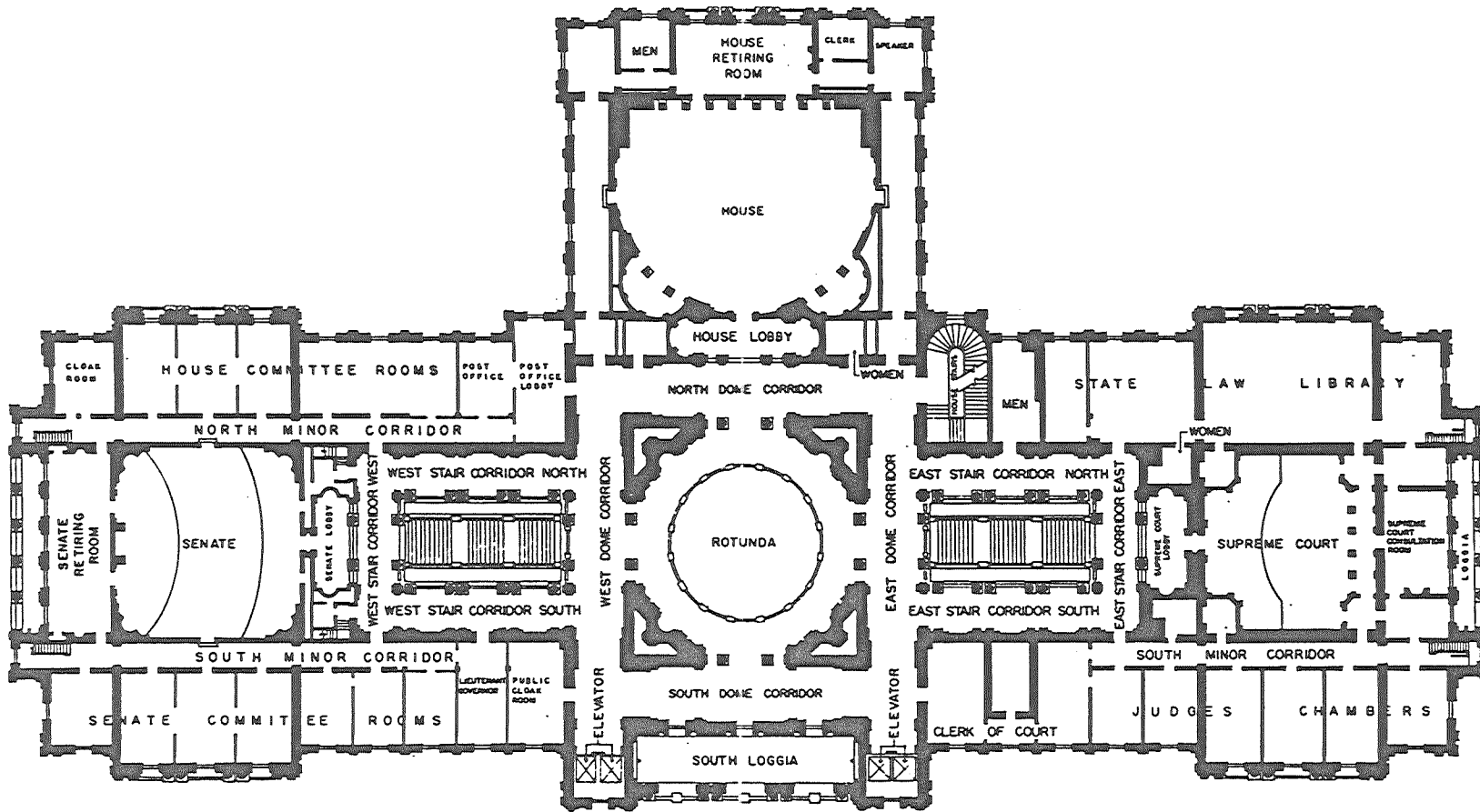

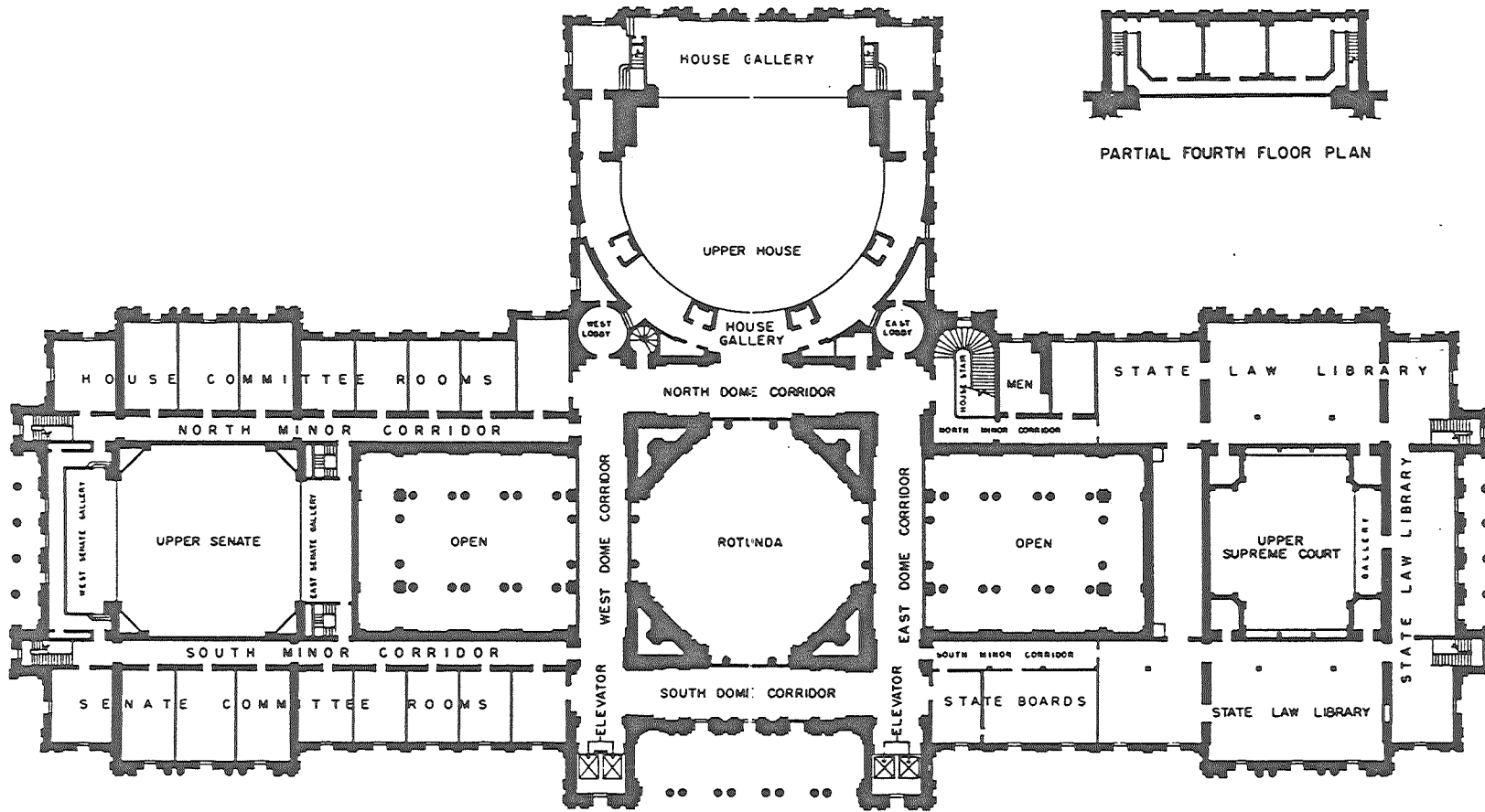

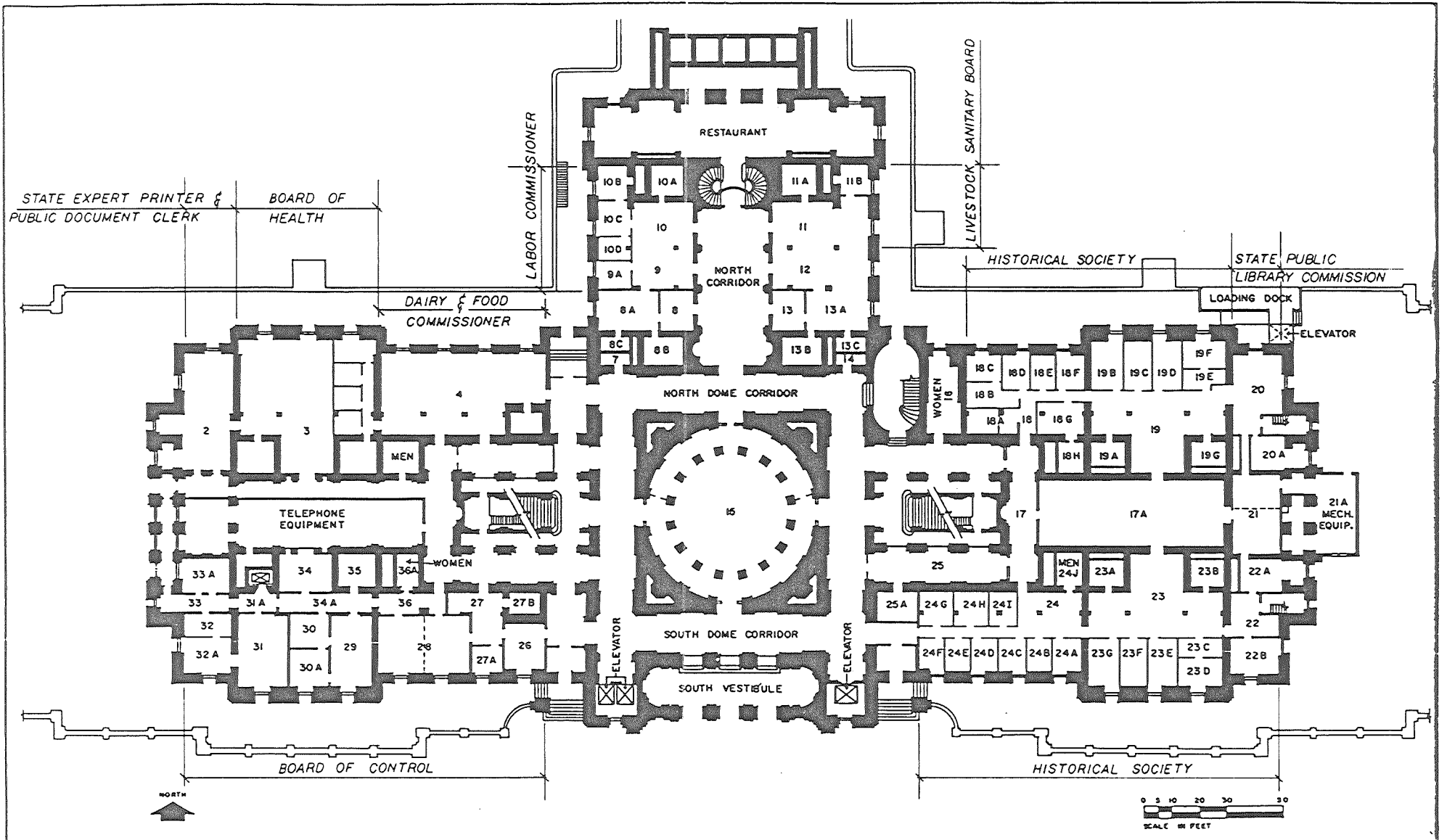

Historic Space Use

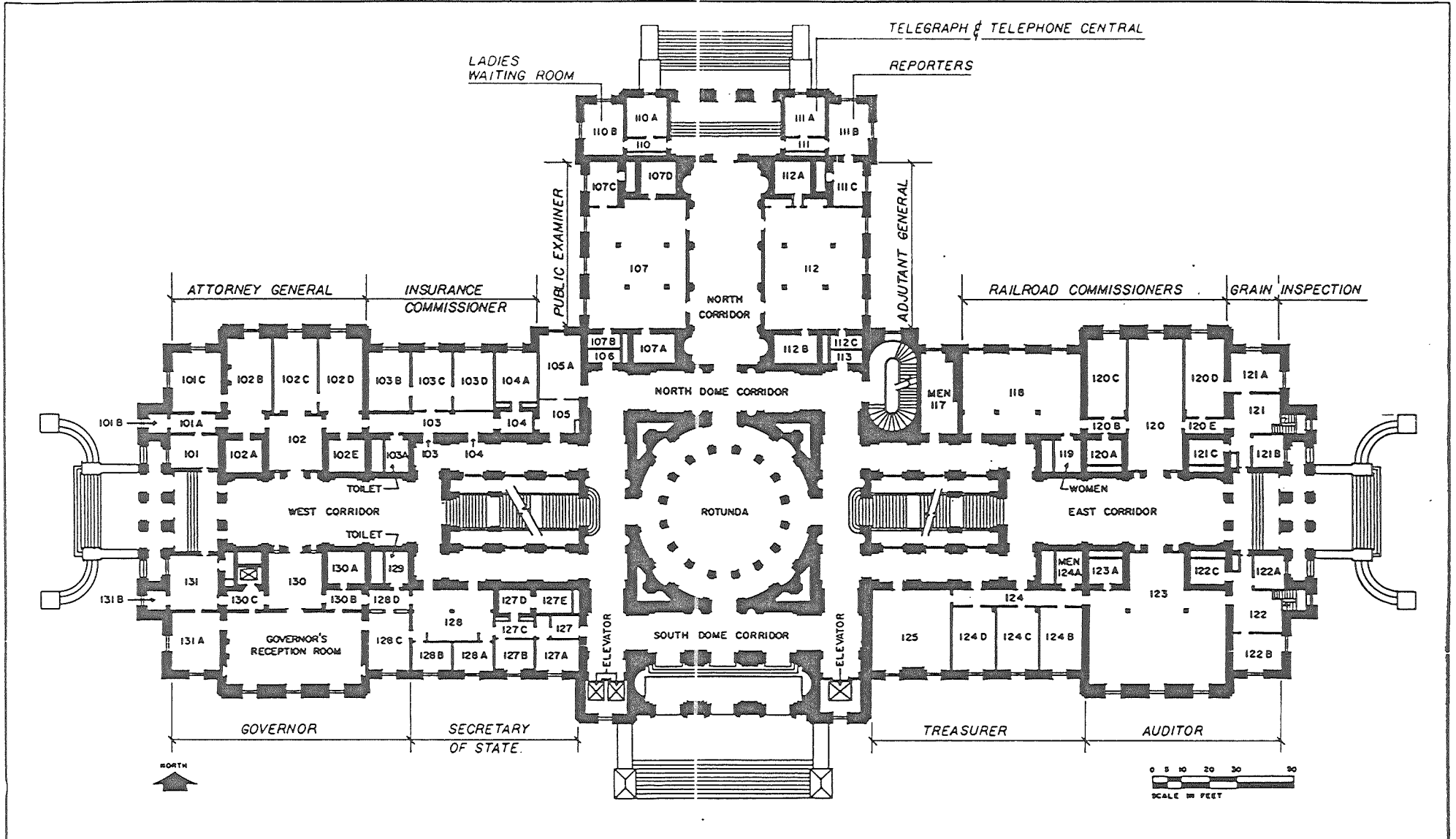
These plans show the original 1905 space assignments in the Capitol which have been superimposed on the present-day plans of the building for comparative purposes.

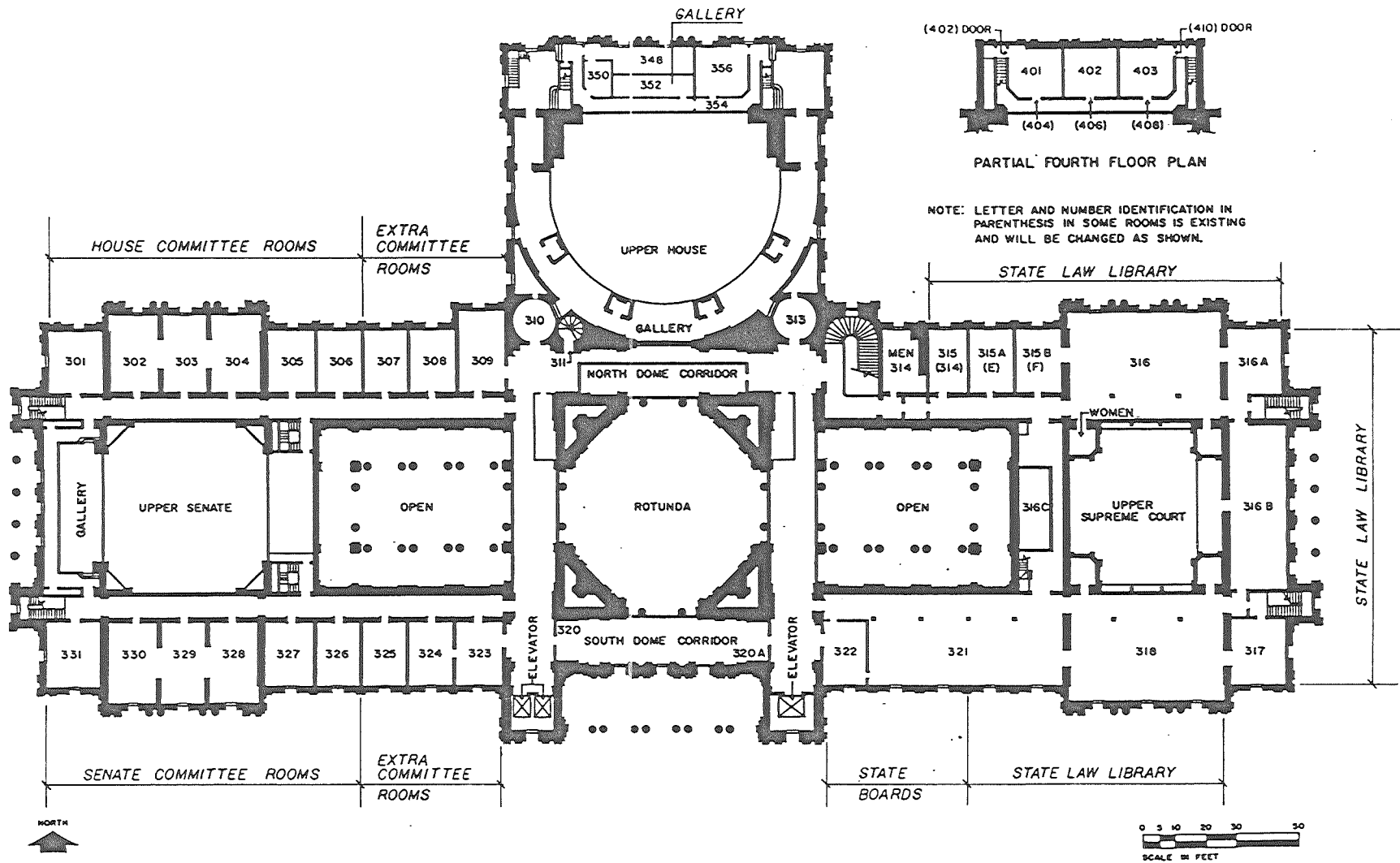

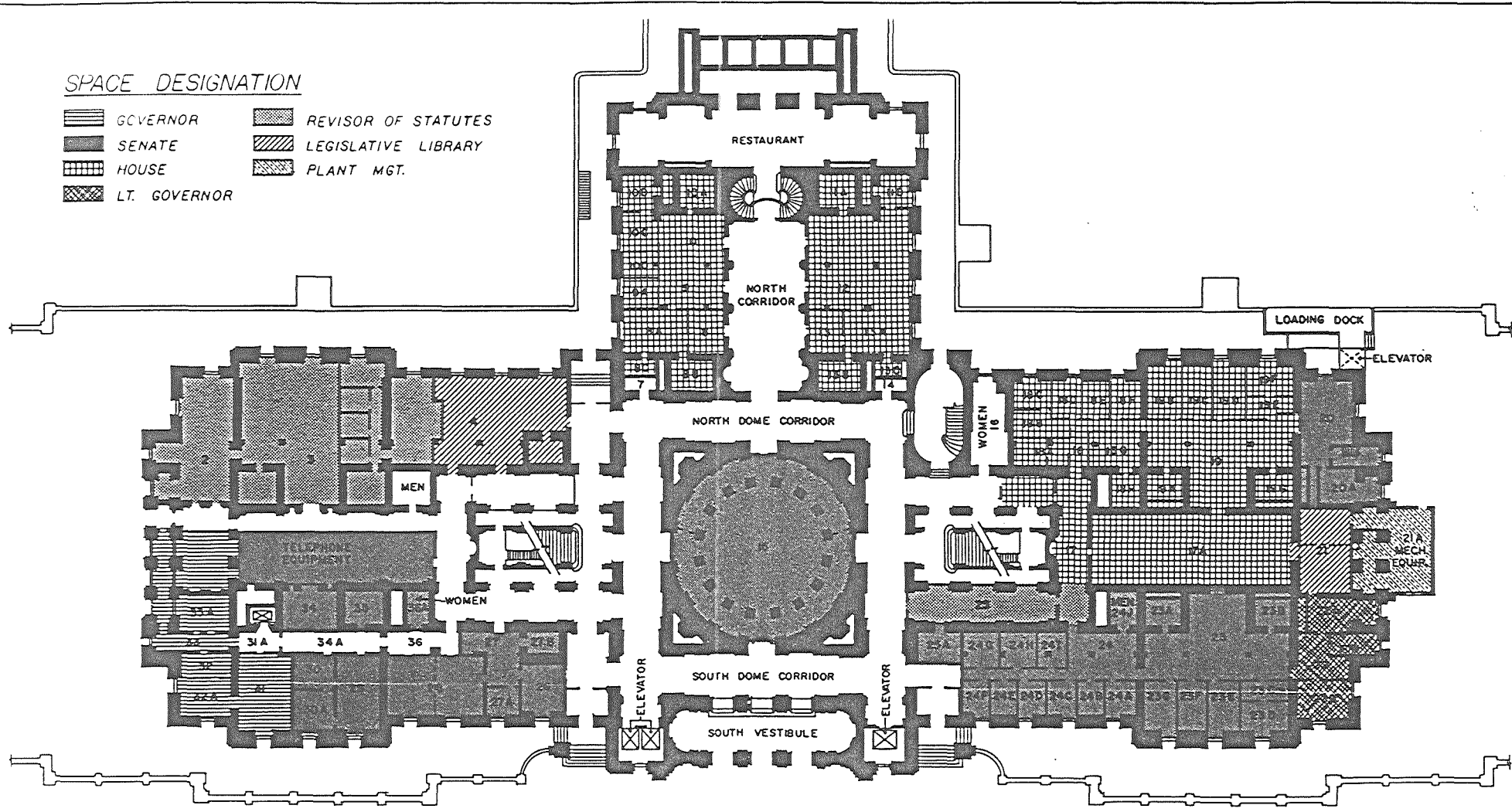
